- **A.** With effect from 01 November 2021 rule 3.5.7 of the Revised Rules shall be replaced as follows:
 - 3.5.7 The BOARD OF TRUSTEES shall have the power to furnish a guarantee in respect of a loan for housing purposes provided by a banking institution, registered under the Banks Act No. 94 of 1990, or any other credit provider registered in terms of the National Credit Act No 34 of 2005, to a MEMBER as referred to in Section 19(5)(a) of the ACT or any equivalent future provision. Such guarantee shall be subject to the requirements of the ACT.
- **B.** With effect from 01 November 2021 Rule 6.2 of Rule Amendment No.1 shall be replaced as follows:

6.2 VOLUNTARY EARLY RETIREMENT

With the consent of his EMPLOYER, a MEMBER other than a DEFERRED RETIREE, may retire from service at any time during the ten-year period preceding his NORMAL RETIREMENT DATE but not earlier than age 50 and be paid the retirement benefit described in the PARTICIPATION CERTIFICATE applicable to the EMPLOYER.
